

Treasurer's Report



Only half of YCE residents have sent their 2025 YCECA dues. We are eager to receive payments from the other half. No one likes asking for money, but we must. In addition to our regular expenses for landscaping, signs, lighting, and irrigation we've had about \$19,000 in extraordinary expenses arising from the storms. Join the current members of the civic

association and send your dues payment today. Simply visit www.yachtclubestates.org and click on the Membership button. Select the level you desire and then follow the prompts. You do not need a PayPal account, just a credit or debit card. If you prefer you can mail us a check or call us and we'll pick up your payment!

Repairs to the bridge are going well. The contractors have been very cooperative. Lane closures have been brief. The route is well marked, and the construction areas are cleared of debris each day. We've had some questions about sidewalks and streets. There are no plans for construction of sidewalks or speed humps in YCE. Based on the average condition of the pavement in YCE our roadways are not targeted for resurfacing in the current City budget cycle. We hope to see pavement operations in 2026.

Parking on the medians and careless driving continue to create problems. Please ask contractors and vendors to park along the street and to observe stop signs and posted speed limits.

support to making this a firstclass newsletter.


